

Terms and conditions

for the purchase of gift vouchers in our online shop
Sepp Baumgartner Tennis Spa Garden - Waging am See

1. General conditions

The mutual contract between the customer and the Sepp Baumgartner Tennis Spa Garden in Waging am See applicable to voucher purchase is based exclusively on these terms and conditions in force at the time of contract conclusion. The following conditions apply to all contracts, supplies and services. Any exceptions must be in writing and must be confirmed by the Tennis Spa Garden.

2. Prices and payment

All prices listed are cash prices. They include the legal VAT and are from D- 83329 Waging am See. Shipping is at customer's risk. The purchase price for the vouchers plus the handling fee is payable immediately upon order. For mail delivery of the vouchers, an extra handling fee of €2.00 is charged.

3. Payment types

Payment can be made by credit card or direct debit. For the purchase of vouchers by credit card, only MasterCard and VISA are accepted. If paying by direct debit, this can be done via a German or Austrian bank account.

4. Payment by direct debit

In choosing to pay by direct debit, the customer authorizes the Tennis Spa Garden Waging am See to collect the invoice amount plus the handling charge (mentioned in 2. above) from the bank account specified. In the case of a debit entry, all related banking fees are charged to the customer.

5. Validity of service and value vouchers

All vouchers offered by the Tennis Spa Garden Waging am See are issued with a mandatory expiration date.

6. Delivery

The vouchers will be sent promptly, at the latest within three days of receipt of the order or receipt of payment.



7. Privacy policy

The information about customers contained in the contract will be saved only for purposes of accounting and processing. The data will be used to satisfy legal requirements, for payment processing and for advertising of the Tennis Spa Garden Waging am See. The customer's data will be treated according to the current Data Protection Act and not forwarded to third parties, except as necessary to fulfill the contract. Should the customer not wish his data to be used for promotional purposes by the Tennis Spa Garden Waging am See, he is entitled to object to this use at any time by sending an appropriate e-mail to info@seppbaumgartner.de .
